Directors' Profile

Dato' Jorgen Bornhoft D.P.T.J. (Kehormat) Chairman Member of Remuneration Committee Member of ESOS Committee

Dato' Jorgen Bornhoft, aged 63, a Dane, is the Chairman of Carlsberg Brewery Malaysia Berhad ("CBMB"), and has been heading the Carlsberg organisation since 1991. Dato' Bornhoft was appointed to the Board on 30 October 1995. He was appointed Chief Executive Officer of Carlsberg Asia Pte Ltd in Singapore on 28 January 2003.

Dato' Bornhoft holds a degree in Accountancy and Financing (Bachelor of Commerce) from the Copenhagen Business School, and attended executive management courses at INSEAD. Prior to his appointment to CBMB, Dato' was Vice-President in Carlsberg International A/S, Denmark, responsible for foreign subsidiaries and new projects. He was also responsible for licence agreements in Asia. In the 1980s, Dato' was appointed as General Manager of a brewery in Greece.

Dato' was a President of the Malaysian International Chamber of Commerce and Industry from 1996 to 1999.

Currently, the directorships held by Dato' Bornhoft in public companies are ABN Amro Bank Bhd (Malaysia), Hap Seng Consolidated Bhd (Malaysia), The Ceylon Brewery Ltd (Sri Lanka), The Lion Brewery Ceylon Ltd (Sri Lanka), Hite Brewery Co. Ltd (South Korea), Lao Brewery Co. Ltd (Laos), Carlsberg Thai Co. Ltd (Thailand) and Carlsberg Brewery Hong Kong Ltd (Hong Kong).

Mr Chan Hua Eng, aged 76, a Malaysian, was appointed to the Board on 6 December 1971.

Mr Chan is a law graduate with Honours from the University of Bristol, a Barrister-at-Law of Middle Temple and an Associate Member of the Institute of Taxation, United Kingdom. He was previously a Senior Partner at Shearn Delamore & Co., Chairman of the Malaysian Bar Council, part-time Judicial Commissioner and Chairman of the Sabah Inquiry Commission.

Mr Chan presently serves on the Boards of Lafarge Malayan Cement Bhd, Lingui Development Bhd, Rohas-Euco Industrial Bhd, Pacific & Orient Bhd and Glenealy Plantations (Malaya) Bhd. He is also a Board Member of the Malaysian Danish Business Council.

Gen. (R) Tan Sri, aged 76, a Malaysian, was appointed to the Board on 11 July 1997.

Gen. (R) Tan Sri possesses numerous military qualifications from the United Kingdom, namely, Military Officer from the Royal Military College, Sandhurst, Military Command & Staff from the Staff College Camberly, Military Intelligence from the Staff Intelligence Ashford and Joint Services from Staff College Latimar. He retired as the Chief of Armed Forces after 35 years of service with the Malaysian Armed Forces. He has also served as a Senator in the Malaysian Parliament and as a Vice-President with the Ex-Servicemen Association.

Currently, Gen. (R) Tan Sri holds directorships in Nestle (Malaysia) Bhd, ABN Amro Bank Bhd and Pacific & Orient Insurance Co. Bhd. He also holds positions in various organisations, namely, Distinguished Fellow with the Institute of Strategic and International Studies (ISIS), Chairman of the Board of Trustees of Yayasan Amanah Pembinaan Insan, Chairman of the Board of Trustees of the Neuro Surgical Foundation, Chairman of the Retired Armed Forces Officers Club, Member of the Board of Trustees of the Johore Malay Chamber of Commerce of Malaysia and Chairman of the Investment Panel, Armed Forces Provident Fund (LTAT).

Tan Sri Datuk Asmat bin Kamaludin, aged 61, a Malaysian, was appointed to the Board on 1 February 2001.

Tan Sri obtained a Bachelor of Economics (Honours) degree from the University of Malaya and later attended a special programme on the European Economic Community in Amsterdam. Tan Sri served in the Ministry of International Trade and Industry (MITI) for 35 years, and retired as its Secretary General, a position he held for 9 years. Dealing with both domestic and international trade sectors at MITI, he had also worked with several international bodies such as ASEAN, WTO and APEC, representing Malaysia in relevant negotiations and agreements. He was also actively involved in several national organisations such as Johor Corporation, the Small and Medium Scale Industries and MATRADE.

Currently, Tan Sri is a Board Member of Malaysian Pacific Industries Bhd, UMW Holdings Bhd, Lion Industries Corporation Bhd, YTL Cement Bhd, Commerce-Asset Holdings Bhd, Matsushita Electric Company (Malaysia) Bhd, Symphony House Bhd, SCOMI Group Bhd, Permodalan Nasional Bhd and Salwan Corporation Bhd. Dato' Lim Say Chong, aged 64, a Malaysian, was appointed to the Board on 21 May 2003.

Dato' Lim obtained a Bachelor of Arts with Honours from the University of Malaya and a Masters in Business Administration from the University of British Columbia, Canada. He also attended an Advanced Management Programme at the Harvard Business School, Boston. Dato' Lim worked with the Imperial Chemical Industries (ICI) Plc's Group of Companies in Malaysia and abroad for 30 years, during which time he sat on the Boards of several companies within the Group. He later became the Managing Director of the ICI (Malaysia) Group for 5 years. Dato' Lim was the Group Managing Director of Chemical Company of Malaysia Bhd from 1989 to September 2004.

Presently, Dato' Lim is a Director of Standard Chartered Bank Malaysia Bhd, Kinta Kellas Public Limited Company and Rohas Euco Industries Bhd. Dato' Lim also served in various associations, including as President of Malaysian International Chamber of Commerce & Industry (MICCI), Vice President of the National Chamber of Commerce & Industry of Malaysia (NICCIM) and Vice Chairman of the British Malaysian Industry & Trade Association. He was also a member of the National Human Resource Development Council, Malaysian Industrial Development Authority (MIDA), Board of Trustees of the Aged European Fund, council member of the Federation of Malaysian Manufacturers (FMM) and Board of ASEAN Chamber of Commerce & Industry (ACCI). Mr Jesper B. Madsen, aged 50, a Dane, was appointed to the Board on 21 May 2003.

Mr Madsen obtained a Masters of Law from Copenhagen University, Denmark and later studied Scottish/English law at the University of Edinburgh, Scotland. Mr Madsen worked in the legal field for 4 years. He has since been working with the Carlsberg A/S Group for 21 years, beginning his career within the Group as a Personal Assistant to the CEO of Carlsberg International. Mr Madsen subsequently held positions as the Vice President responsible for overseas investments/markets, General Manager and Managing Director of Carlsberg Brewery Hong Kong Ltd and Chief Operating Officer of Carlsberg Asia Pte Ltd. In August 2003, Mr Madsen was appointed as Senior Vice President of Carlsberg Breweries A/S with responsibility for Asia, among other markets.

Presently, Mr Madsen is the Chairman of Carlsberg Brewery (Guangdong) Ltd (China), Hue Brewery Ltd (Vietnam) and South East Asia Brewery Ltd (Vietnam). He is also the Vice Chairman of Kunming Huashi Brewery Company Ltd (China) and Dali Beer (Group) Limited Co. (China) and is a Board member of Carlsberg Brewery Hong Kong Ltd (Hong Kong), Carlsberg Hong Kong Ltd (Hong Kong), Carlsberg Malawi Brewery Ltd., The Bottling and Brewing Group Limited (Malawi) and Lao Brewery Co. Ltd (Laos), Lanzhou Huanghe Jiaiang Brewery Company Limited (China), Qinghai Huanghe Jiaiang Brewery Company Limited (China), Tibet Lhasa Brewery Company Ltd (China) and Gorkha Brewery Ltd (Nepal). Mr Madsen also sits on the Boards of several private companies within the Carlsberg Breweries A/S Group. Mr Bjorn Sondenskov, aged 43, a Dane, was appointed to the Board on 1 April 2003.

Mr Sondenskov holds a Bachelor of Science (Economics) degree from the Copenhagen Business School and a Diplome (a European Masters in General Management) from Ecole Europeenne des Affaires (Paris-Oxford-Berlin) which is part of the Chamber of Commerce and Industry in Paris. He is currently the Vice President in the Asia, Balkan and Export & Licence Division in Carlsberg Breweries A/S. Mr Sondenskov was the Managing Director of CBMB from 1 April 2003 to 1 July 2004. Prior to his appointment to CBMB, Mr Sondenskov was the Director/Chief Financial Officer and member of the Management Board of Hannen Brauerei GmbH, Germany, responsible for finance, controlling, information technology and production. Mr Sondenskov worked with the Carlsberg Breweries A/S Group for 16 years, holding various senior positions such as Regional Manager, General Manager and Senior General Manager. He was later appointed Group Vice-President of the Carlsberg Breweries A/S Group and was subsequently made responsible for the Western Europe and Exports Division within the Group.

Mr Sondenskov serves on several private companies within the Carlsberg Breweries A/S Group.

Mr Mogens Joenck, aged 51, a Dane, was appointed as the Managing Director of CBMB on 1 January 2005.

Mr Joenck holds a MSc in Marketing and Economics from the Copenhagen Business School and attended executive management courses at Stanford University. Prior to his appointment to CBMB, since 1999, he was the Group Chief Executive Officer of Kilroy Travels International A/S, one of Northern Europe's leading leisure travel operators. Mr Joenck was with the Carlsberg Denmark Group from 1980 to 1999 and held various managerial positions within the sales and marketing divisions of Carlsberg A/S (Denmark) and Tuborg Breweries A/S (Denmark). In 1987, he was the personal assistant to the Managing Director of CBMB for 1 year, with operational responsibility for one of the subsidiary companies of CBMB. Mr Joenck's last position in the Carlsberg A/S Group was as Senior Vice-President as well as a member of the top management of Carlsberg Division Denmark, where he was responsible for sales, marketing, product development and logistics, and for the merger of the sales organisations of Carlsberg and Tuborg in Denmark.

Mr Joenck does not hold any directorships in public companies.

Mr Chin Voon Loong, aged 48, a Malaysian, was appointed as a Director on 1 April 2003.

Mr Chin obtained a Bachelor of Science (Honours) degree in Systems and Management from The City of London University and is a Fellow Member of the Institute of Chartered Accountants in England and Wales. He is also a Chartered Accountant with the Malaysian Institute of Accountants, an Associate Member of the Malaysian Institute of Taxation and a Member of the Institute of Company Secretaries, Malaysia. He was employed by Messrs Ernst & Whinney in London and subsequently, by the same firm in Kuala Lumpur. Mr Chin has worked with CBMB for 18 years. After holding the position of Chief Financial Officer and subsequently, as Commercial Director with Carlsberg Marketing Sdn Bhd, he currently holds the position of Executive Director-Corporate Affairs/Company Secretary of CBMB.

Currently, the directorships held by Mr Chin in public companies are The Lion Brewery Ceylon Ltd (Sri Lanka), South East Asia Brewery Ltd (Vietnam) and International Beverage Distributors Ltd (Vietnam). He also serves on the Boards of several private companies within the Carlsberg Asia Pte Ltd Group.

Chairman's Statement

On behalf of the Board of Directors of Carlsberg Brewery Malaysia Berhad, I am pleased to present the Annual Report and the Audited Financial Statements of the Group and the Company for the financial year ended 31 December 2004.

OVERVIEW

2004 had been a most challenging year for the Malaysian brewery industry.

Before recovery had taken place from the effects of the 10% increase in the excise duties for beer and stout imposed on 12 September 2003, the Government announced a further 26.3% and 23.0% increase in excise duties for beer and stout respectively on 10 September 2004. The resulting price increase has affected the growth of the local duty-paid beer and stout market in the last quarter of 2004. This was made worse by the lower increase in duties for hard liquor and wine, of only between 2.2% to 13.6%, increasing the relative affordability of these high alcohol content products.

The growing presence of low priced imported beer and smuggled beer continue to affect the growth of the duty paid local beer and stout markets.

The effect of the Government's action in implementing "tax stamps" for imported beer and hard liquor products to ensure that duties are paid for all imported alcoholic products commencing 1 April 2005 is yet to be known. Meanwhile, competitive activities within the beer and stout industry in Malaysia remained at a high level.

The Group, under such circumstances, continued to maintain its market leadership position in the beer market and sustained a

commendable market share in the stout market through strategic and innovative marketing and sales activities.

OPERATING RESULTS

Group revenue increased by 12.4% or RM108.8 million for the year under review to RM984.8 million. The increase in revenue was primarily due to the price increases after the September 2003 and September 2004 excise duty increases and the growth in export sales. Group profit before tax at RM113.3 million was higher than 2003 by 6.2% or RM6.7 million.

Earnings per share after tax for 2004 was 58.0 sen or 9.0% higher compared to 53.1 sen in 2003. In view of the high dividend payout in 2004, the Group's net tangible assets per share decreased by 2.4% to RM3.27 per share from RM3.35 per share. Shareholders' funds declined by 2.2% to RM500.5 million from RM511.7 million in 2003.

REVIEW OF OPERATIONS

During the year, the Group increased its marketing activities and trade promotions to further enhance the high brand equity of the Carlsberg Green Label brand as well as to address the intense competitive local beer and stout environment. As part of the Group's on-going strategy to strengthen its brand portfolio, the Group introduced its new beer brand, SKOL, in September 2004. The Group is confident that SKOL, the world's third largest selling beer brand, will be a successful complement to its existing brands in Malaysia.



The Group launched a major National marketing campaign for Carlsberg Green Label in the run-up to the Euro 2004 football event, for which Carlsberg had been the "Official Beer" since Euro 88. In connection with the international campaign, the Group also produced limited edition Carlsberg Green Label bottles and can packaging. On a global scale, Carlsberg Green Label has for the second consecutive year, maintained its position as the fastest growing international lager beer brand in the world.

During the year, the Group presented a new Danish Royal Stout bottle shape, with a contemporary, revitalised design and packaging. Special Brew's packaging was also enhanced with a gold, classy premium look, whilst preserving its strong original taste.

The Group's strong commitment to sports development continued throughout 2004 with major sponsorships in various sports. Major sponsorships undertaken during the year included the 2004 Carlsberg Malaysian Golf Open which was broadcasted to over 50 countries around the world and the Cobra Invitational Rugby.

In respect of community service and the promotion of local artistes, the Group continued to sponsor the Carlsberg-Nanyang Top Ten Charity Concert. This event which comprises a charity roadshow of concerts featuring local artistes, has been given the honour of being the longest charity road show in Malaysia. In its seventeenth year, the annual campaign has raised total funds to-date in excess of RM250 million. More than 500 primary and secondary schools as well as institutions of higher learning have benefited from this sponsorship. The Group also continued its support of the Indian community through its contribution to the Education, Welfare and Research Foundation of Malaysia.

The Group remains committed to the highest product quality, where its brewery continues to operate in accordance with the highest standards set by the Carlsberg Quality Group in Denmark. The Group's brewery, after being assessed over the period from 1 January to 31 December 2004 was awarded a certificate by its Group's headquarters in Denmark, which ranked the Group's Carlsberg Green Label in bottles and cans amongst the best of more than 70 Carlsberg breweries in the world. The Group has further proven that the quality standards practised at the brewery meets independent International Standards by being awarded the ISO9001:2000 and HACCP certificates.

CORPORATE EXERCISES

Share split

The Board of Directors has proposed a share split of each ordinary share of RM1.00 each in Carlsberg Brewery Malaysia Berhad into 2 new ordinary shares of RM0.50 each.

Share buy-back

There was no further buyback of shares during the year under review. The 1,165,000 ordinary shares representing 0.76% of the issued and paid up share capital of the Company purchased in 1999 at an average price of RM10.34 per share, have been retained as treasury shares.

The Board of Directors have recommended to the shareholders to approve, amongst others, the proposed share split and the

proposed renewal of the share buy-back programme. The details of these proposals are included in the Circular to shareholders.



OVERSEAS INVESTMENT

The Lion Brewery Ceylon Ltd (TLBCL) performed satisfactorily during the year under review. The Group's share of the income from TLBCL for the twelve months to 30 September 2004 amounting to RM3.3 million had been included in the financial statements for 2004.

BOARD COMMITTEES

The various Board Committees have met in 2004 and were effective in maintaining the Group's good corporate governance standards. Details of the roles and responsibilities of the Board Committees are set out in the Statement of Corporate Governance.

DIVIDENDS

The Company paid a gross interim dividend of 10 sen per share less Malaysian income tax and a gross special interim dividend of 5 sen per share less Malaysian income tax on 8 October 2004. The total interim dividend paid was RM16.5 million, which was RM5.5 million higher than the interim dividend paid in 2003.

The Board is recommending the payment of a final gross dividend of 15 sen per share less Malaysian income tax in respect of the 2004 financial year.

After reviewing the Group's funding requirements and strategic needs, the Board is also recommending the payment of a special gross dividend of 70 sen per share less Malaysian income tax.

Collectively with the interim dividends, the Company's total dividend payout for 2004 will be RM110.1 million or 18.0% higher than 2003.

The above dividends are subject to shareholders' approval. Upon approval, the final and special dividends will be paid on 18 May 2005.

OUTLOOK FOR 2005

The Government's substantial increase in excise duties and the resulting price increase by the industry would adversely affect the growth of the beer and stout market. The inequitable increase in duties for imported beer and hard liquor resulting in the narrowing of the price gap and affordability may result in higher consumption especially of hard liquor, which would pose even greater challenges to the domestic beer and stout market. The growing availability of low priced imported beers and smuggled beer and stout products would also have a negative effect on the consumption of local duty-paid beer and stout unless the implementation of the "tax stamp" for imported alcoholic products initiative by the Government is enforced effectively.

The Group expects the competition to remain at high levels in the foreseeable future. The Group will focus its efforts and resources to continue its market leadership in the beer sector and increase its market share in the stout segment.

In the light of the above circumstances, the Group expects 2005 to be extremely challenging.

APPRECIATION

On behalf of the Board, I would like to welcome Mr Mogens Joenck who was appointed to the Board on 1 January 2005 as Managing Director, replacing myself, who resigned as Executive Chairman on 1 January 2005 and Mr Bjorn Sondenskov, who resigned as Managing Director on 1 July 2004. Mr Sondenskov and I remain as Non-Executive Director and Non-Executive Chairman of Carlsberg Brewery Malaysia Berhad respectively.

I wish to take this opportunity, on behalf of the Board and Management of Carlsberg Brewery Malaysia Berhad, to thank all the shareholders, wholesalers, customers and consumers for their continued confidence and support of the Group.

I also wish to express the Board's appreciation to the Management and all the employees of the Group for contributing to the performance of the Group through their dedication and commitment.

Sebelum industri ini pulih akibat kesan kenaikan duti eksais bir dan stout sebanyak 10 peratus yang telah dikuatkuasakan pada 12 September 2003, pihak Kerajaan telah mengumumkan kenaikan duti eksais sebanyak 26.3 peratus untuk bir dan 23 peratus untuk stout pada 10 September 2004. Kenaikan harga bir dan stout tersebut telah melembapkan pertumbuhan pasaran bir dan stout tempatan duti berbayar pada suku akhir tahun 2004. Keadaan ini diburukkan lagi oleh kenaikan duti yang lebih rendah bagi minuman keras dan wain, yang hanya di antara 2.2 peratus hingga 13.6 peratus, meningkatkan kemampuan pembelian produk-produk berkandungan alkohol tinggi.

Di samping itu, pertambahan kehadiran bir import berharga murah dan bir seludup yang sedia ada terus menjejaskan pertumbuhan pasaran bir dan stout tempatan duti berbayar.

Kesan tindakan Kerajaan Malaysia dalam melaksanakan 'setem cukai' untuk produk bir dan minuman keras import bagi memastikan duti dibayar bagi semua produk beralkohol yang diimport bermula 1 April 2005 masih belum diketahui. Di samping itu, kegiatan persaingan di kalangan industri bir dan stout di Malaysia kekal pada tahap yang tinggi. Namun begitu, di dalam keadaan ini, Kumpulan masih terus mengekalkan kedudukannya sebagai peneraju dalam pasaran bir dan mempertahankan agihan pasarannya yang dapat dibanggakan dalam pasaran stout melalui kegiatan pemasaran dan jualan yang strategik dan inovatif.

KEPUTUSAN OPERASI

Bagi tahun yang dikaji, perolehan Kumpulan adalah RM984.8 juta, iaitu meningkat sebanyak 12.4 peratus atau RM108.8 juta. Peningkatan perolehan sebahagian besarnya adalah disebabkan oleh kenaikan harga selepas kenaikan duti eksais pada September 2003 dan September 2004 serta pertumbuhan dalam jualan eksport. Keuntungan Kumpulan sebelum cukai adalah RM113.3 juta, iaitu meningkat sebanyak 6.2 peratus atau RM6.7 juta berbanding dengan tahun 2003.

Bagi tahun 2004, pendapatan sesaham selepas cukai adalah 58.0 sen atau 9.0 peratus lebih tinggi berbanding dengan 53.1 sen pada tahun 2003. Memandangkan pembayaran dividen yang tinggi pada tahun 2004, aset ketara bersih sesaham bagi Kumpulan menurun sebanyak 2.4 peratus kepada RM3.27 sesaham daripada RM3.35 sesaham. Dana pemegang saham berjumlah RM500.5 juta, menurun sebanyak 2.2 peratus daripada RM511.7 juta pada tahun 2003.



ULASAN OPERASI

Sepanjang tahun yang dikaji, Kumpulan telah meningkatkan kegiatan pemasaran dan promosi perdagangan untuk mempertingkatkan lagi ekuiti tinggi jenama Carlsberg Green Label dan juga menghadapi persaingan sengit persekitaran bir dan stout tempatan. Sebagai sebahagian daripada strategi berterusan Kumpulan untuk mengukuhkan rangkaian jenamanya, Kumpulan telah memperkenalkan bir barunya, SKOL pada September 2004. Kumpulan yakin SKOL, jenama bir yang ketiga laris jualannya di dunia akan berjaya dalam melengkapkan jenama-jenamanya yang sedia ada di Malaysia.

Kumpulan melancarkan satu kempen pemasaran Kebangsaan utama untuk Carlsberg Green Label sempena menyambut kedatangan acara bolasepak Euro 2004, di mana Carlsberg merupakan 'Bir Rasmi' acara tersebut sejak Euro 88. Sehubungan dengan kempen antarabangsa tersebut, Kumpulan turut mengeluarkan pembungkusan botol dan tin edisi terhad Carlsberg Green Label. Dari sudut global, Carlsberg Green Label, telah mempertahankan kedudukannya sebagai jenama bir lager antarabangsa yang terpantas pertumbuhannya di dunia untuk dua tahun berturut-turut.

Sepanjang tahun yang dikaji, Kumpulan juga memperkenalkan bentuk botol baru Danish Royal Stout, dengan rekabentuk dan pembungkusan yang kontemporari dan terkini. Pembungkusan Special Brew turut dipertingkatan dengan warna keemasan, mencerminkan taraf tinggi dan premium, disamping mengekalkan rasa asalnya.

Komitmen gigih Kumpulan dalam pembangunan sukan diteruskan sepanjang 2004 melalui penajaan utama dalam pelbagai kegiatan sukan. Kegiatan penajaan utama yang dilaksanakan pada tahun berkenaan adalah Carlsberg Malaysia Golf Open 2004 yang telah disiarkan kepada lebih daripada 50 buah negara di seluruh dunia dan Cobra Invitational Rugby.

Dalam hal perkhidmatan komuniti and promosi artis-artis tempatan, Kumpulan terus menaja Persembahan Amal Carlsberg-Nanyang Top Ten. Acara ini adalah satu persembahan amal oleh artis-artis tempatan, yang telah diberikan anugerah program amal yang paling lama dijalankan di Malaysia. Dalam tahun ketujuh-belasnya, kempen tahunan ini sehingga kini telah mengumpul jumlah dana melebihi RM250 juta. Lebih daripada 500 buah sekolah rendah dan menengah Cina serta institusi pengajian tinggi telah mendapat manfaat daripada tajaan ini. Kumpulan juga terus memberi sokongannya terhadap komuniti India melalui sumbangannya kepada Yayasan Pendidikan, Kebajikan dan Penyelidikan Malaysia.

Kumpulan mengekalkan komitmennya terhadap kualiti produk yang tertinggi, di mana kilang birnya terus beroperasi mengikut piawaian tertinggi yang telah ditetapkan oleh Kumpulan Kualiti Carlsberg di Denmark. Kilang Kumpulan, setelah dinilai dari tempoh 1 Januari hingga 31 Disember 2004, telah dianugerahkan satu sijil oleh ibu pejabat Carlsberg, yang meletakkan botol dan tin Carlsberg Green Label Kumpulan di antara yang terbaik di kalangan lebih daripada 70 buah kilang bir Carlsberg di dunia. Kumpulan selanjutnya membuktikan bahawa piawaian kualiti yang dipraktikkan di kilang bir memenuhi Piawaian Antarabangsa yang bebas apabila dianugerahkan sijil ISO9001:2000 dan sijil HACCP.

LANGKAH KORPORAT

Pembahagian saham

Lembaga Pengarah telah mencadangkan pembahagian saham bagi setiap saham biasa bernilai RM1.00 sesaham dalam Carlsberg Brewery Malaysia Berhad kepada 2 saham biasa baru bernilai RM0.50 sesaham.

Belian Balik Saham

Tiada belian balik saham yang seterusnya dilakukan sepanjang tahun yang dikaji. Sebanyak 1,165,000 saham biasa mewakili 0.76 peratus modal saham terbitan dan berbayar bagi Syarikat yang dibeli pada 1999 pada harga purata RM10.34 sesaham dipegang sebagai saham perbendaharaan.

Lembaga Pengarah telah mengesyorkan kepada para pemegang saham supaya meluluskan di antaranya cadangan pembahagian saham dan pembaharuan program belian balik saham. Butiran cadangan-cadangan tersebut telah dilampirkan dalam Pekeliling kepada pemegang saham.

PELABURAN LUAR NEGARA

The Lion Brewery Ceylon Ltd (TLBCL) mencatatkan prestasi yang memuaskan sepanjang tahun yang dikaji. Jumlah pendapatan Kumpulan daripada TLBCL untuk 12 bulan sehingga 30 September 2004 berjumlah RM3.3 juta telah dimasukkan ke dalam penyatapenyata kewangan untuk 2004.

JAWATANKUASA-JAWATANKUASA LEMBAGA

Semua Jawatankuasa Lembaga telah mengadakan mesyuarat dalam tahun 2004 dan berkesan dalam mengekalkan standard tadbir urus korporat Kumpulan yang baik. Butir-butir peranan dan tanggungjawab Jawatankuasa-jawatankuasa Lembaga telah dibentang dalam Penyata Tadbir Urus Korporat.

DIVIDEN

Syarikat telah membayar dividen kasar interim sebanyak 10 sen sesaham ditolak cukai pendapatan Malaysia dan dividen kasar istimewa interim sebanyak 5 sen sesaham ditolak cukai pendapatan Malaysia pada 8 Oktober 2004. Jumlah dividen interim yang dibayar adalah RM16.5 juta, iaitu meningkat sebanyak RM5.5 juta berbanding dividen interim yang telah dibayar pada 2003.

Lembaga Pengarah mengesyorkan pembayaran dividen kasar muktamad sebanyak 15 sen sesaham ditolak cukai pendapatan Malaysia bagi tahun kewangan 2004.

Selepas mengambil kira peruntukan dana Kumpulan untuk keperluan operasi dan strategik, Lembaga Pengarah turut mengesyorkan pembayaran dividen kasar istimewa sebanyak 70 sen sesaham ditolak cukai pendapatan Malaysia.

Secara kolektif termasuk dividen interim, jumlah dividen yang dibayar oleh Syarikat untuk 2004 adalah RM110.1 juta atau 18.0 peratus lebih tinggi daripada 2003.

Dividen-dividen di atas tertakluk kepada kelulusan para pemegang saham. Apabila diluluskan, dividen muktamad dan istimewa akan dibayar pada 18 Mei 2005.

TINJAUAN TAHUN 2005

Kenaikkan duti eksais yang tinggi yang sebelum ini tidak pernah dilakukan oleh Kerajaan dan disusuli oleh tindakan industri menaikkan harga akan memberi kesan negatif terhadap pertumbuhan pasaran bir dan stout. Kenaikan duti bir import dan minuman keras yang tidak saksama mengakibatkan jurang perbezaan harga semakin kecil dan kemampuan pembelian akan mengakibatkan pertambahan penggunaan terutamanya minuman keras, yang bakal memberikan persaingan lebih sengit kepada pasaran bir dan stout tempatan. Kehadiran semakin banyaknya bir import yang berharga rendah dan produk bir dan stout seludup juga dijangka memberikan kesan negatif terhadap penggunaan bir dan stout tempatan duti berbayar melainkan usaha pelaksanaan 'setem cukai' untuk produk alkohol import oleh kerajaan dikuatkuasakan dengan berkesan.

Kumpulan menjangka persaingan akan kekal pada tahap tinggi untuk masa akan datang. Kumpulan akan terus menumpukan usaha dan sumber-sumbernya untuk meneruskan kedudukannya sebagai peneraju pasaran bir dan meningkatkan agihan pasarannya dalam segmen stout.

Memandangkan keadaan yang disebutkan di atas, Kumpulan menjangka tahun 2005 amat mencabar.

PENGHARGAAN

Bagi pihak Lembaga Pengarah, saya ingin mengucapkan selamat datang kepada Encik Mogens Joenck yang dilantik menyertai Lembaga Pengarah pada 1 Januari 2005 sebagai Pengarah Urusan, menggantikan saya, yang meletak jawatan sebagai Pengerusi Eksekutif pada 1 Januari 2005 dan Encik Bjorn Sondenskov, yang meletak jawatan sebagai Pengarah Urusan pada 1 Julai 2004. Saya akan terus kekal sebagai Pengerusi Bukan Eksekutif dan Encik Sondenskov sebagai Pengarah Bukan Eksekutif Carlsberg Brewery Malaysia Berhad.

Saya ingin mengambil kesempatan ini, bagi pihak Lembaga Pengarah dan Pengurusan Carlsberg Brewery Malaysia Berhad, mengucapkan terima kasih kepada para pemegang saham, pemborong, pelanggan dan pengguna atas keyakinan dan sokongan yang berterusan terhadap Kumpulan.

Saya juga ingin menyampaikan penghargaan pihak Lembaga Pengarah kepada Pengurusan dan semua kakitangan Kumpulan atas sumbangan mereka kepada prestasi Kumpulan melalui dedikasi dan komitmen vang diberikan.

主席献词

本人欣然代表马来西亚皇帽酿酒厂有限公司 董事部同仁在此提呈本集团兼公司截至2004年12月31日的 财政年度之常年报告及经审核的财务报告书。

概述

对马来西亚酿酒业而言, 2004年是个最富有挑战性的年头。

2003年9月12日,啤酒和黑啤的国产税调高10%的措施生效之后,本行业尚未全面复苏,政府又在2004年9月10日宣布 将啤酒和黑啤的国产税分别进一步调高26.3%及23.0%。调整售价后,本地的缴税啤酒与黑啤市场成长率大受影响,尤 其是在2004年最后一个季度。而入口啤酒与烈酒的增税率偏低,只调高介于2.2%至13.6%之间,令入口啤酒与烈酒的价 格更令人负担得起,使情况加剧。

低价的入口啤酒以及走私啤酒,充斥市面的程度有增无减,导致本地啤酒与黑啤市场的增长继续受影响。

政府于2005年3月1日为入口啤酒与烈酒产品实施'缴税印花'制度,以确保所有进口的含酒精饮料均已缴税。这项行动是 否奏效,尚有待观察。另一方面,马来西亚啤酒与黑啤业者之间竞争激烈的活动,继续维持在一个高水平的点位。

在此情况下,本集团继续在啤酒市场上保住领导地位,并透过策略性与革新性的市场与销售活动,在黑啤市场上维持显 著的市场占有额。

营运业绩

本集团在受检讨年度的营业额增加了12.4%或马币一亿零八百八十万令吉,达到九亿八千四百八十万令吉。营业额增加 主要是因为自2003年9月及2004年9月份国产税调高之后的涨价,以及出口销售额的成长。集团的税前盈利达到一亿一 千三百三十万令吉,比 2003年增加6.2%或相等于六百七十万令吉。

2004 年的税后每股净收益利是五十八仙,或比2003年的五十三点一仙增加了9%。有鉴于本集团在2004年派发高股息, 公司的每股净有形资产减少了2.4%,从每股三令吉三十五仙下跌到每股三令吉二十七仙。股东的基金则从2003年的五 亿一千一百七十万令吉递减2.2%,达到五亿零五十万令吉。

业绩检讨

本集团全年锐意展开行销活动与促销宣传,以进一步增强皇帽青色标签的高品牌质量指数,同时应付来自具竞争性的本 地啤酒与黑啤市场环境。本集团不断拟订策略强化其品牌组合,并于2004年9月份趁势推出崭新的SKOL啤酒品牌。本集 团深信SKOL这种全世界销量排行前三名的啤酒,将同样在马来西亚受欢迎,为现有的品牌锦上添花。

2004年欧洲杯足球锦标赛掀开序幕之前,本集团为皇帽青色标签品牌展开全国性强势促销运动,而皇帽自88年的欧洲 杯足球赛以来,便一直是该赛会的'指定啤酒'。配合有关国际性的促销运动,本集团同时也推出限量版瓶装及罐装皇帽 青色标签品牌啤酒。在国际贮藏啤酒品牌中,皇帽青色标签连续两年在全球保持其成长最快速的地位。


本集团同年也呈献了形状崭新的Danish Royal黑啤酒瓶,经过提升后的设计与具富现代感的包装令人耳目一新。至于Special Brew的包装也加以提升,展现高级的金黄色典雅外观,唯却保留其醇厚的原味。

本集团在2004年继续不遗余力对体坛发展作出贡献,成为多个体育项目的主要赞助商。全年赞助的大型盛会包括皇帽马 来西亚高尔夫球公开赛以及COBRA 橄榄球邀请赛。其中马来西亚高尔夫球公开赛传播给全球逾 50 个国家。

本集团贯彻支持社会公益服务以及提倡本地歌艺的宗旨,继续赞助皇帽-南洋十大歌星义演。这项被誉为马来西亚历史

最悠久的慈善巡回演出,获得多位本地艺人参与,巡回各地进行慈善表演。迈入第十七个年头,这项一年一度的活动, 迄今总共筹获逾两亿五千万令吉的基金。通过这项赞助活动,已经有五百多所华小、中学以及高等学府受惠。本集团也 透过马来西亚教育、福利与研究基金会,继续慷慨解囊,支助印裔社群。

本集团仍然不遗余力地维持最上乘的产品素质,酿酒厂的运作继续符合由丹麦皇帽品管小组设定的最高标准。经过从 2004年1月1日至12月31日这段期间的评估之后,本集团荣获哥本哈根皇帽颁发证书,将集团的瓶装及罐装青色标签啤 酒列为全世界70多家酿酒厂生产的最佳品牌之一。本集团也已获颁ISO9001:2000以及HACCP证书,进一步证明酿酒 厂所实践的品质标准符合独立的国际标准。



企业动态

分股

董事部建议将马来西亚皇帽酿酒厂有限公司每股RM1.00的普通股,分为2股每股 RM 0.50的新普通股。

股票回购

在受检讨年度内,并无进一步之股票回购。于1999年以每股十令吉三十四仙的平均价格收购1,165,000股普通股,占了 公司已发出缴足股票资金的0.76%,已被保留为公司之库藏股票。

公司董事部建议股东批准拟议中的分股以及更新股票回购计划,以及其他事项。这些建议方案的细节,已列入致于股东 的通函内。

海外投资

The Lion Brewery Ceylon Ltd (TLBCL) 在受检讨年度的表现令人满意。本集团截至2004年9月30为止,源自TLBCL 的收 入份额总计三百三十万令吉,已收录于2004年度的财务报表内。

董事部委员会

董事部各委员已在2004年开会,并有效地维持本集团之良好企业管治标准。有关董事部委员之角色与职责详情,已列入 企业管治声明内。



股息

公司已在2004年10月8日派发须扣除马来西亚所得税的每股十 仙之中期总股息,以及须扣除马来西亚所得税之每股五仙 的特别总股息。已支付之中期股息总计一千六百五十万令吉,比2003年的中期股息多五百五十万令吉。

董事部建议在2004年的财政年度支付一笔须扣除马来西亚所得税的每股十五仙之终期总股息。

董事部检讨了本集团的融资要求以及策略性需求之后,亦建议支付须扣除马来西亚所得税的每股七十仙之特别总股息。

若与中期股息合计,公司在2004年派发之总股息共为一亿一千零十万令吉,比2003年多出18.0%。

上述股息尚待股东之批准。一旦获得批准,终期股息及特别股息将于2005年5月18日派发。

2005年展望

政府大幅度调高国产税,导致业者的产品顺势涨价,势必严重影响啤酒与黑啤市场的增长。进口啤酒与烈酒的不平等增 税幅度,将导致售价差距收窄,尤其在更多人负担得起饮用烈酒的情况下,国内的啤酒与黑啤市场难免面对更大的挑战。

低价的进口啤酒、走私啤酒以及黑啤产品越来越垂手可得,亦将为本地已缴税之啤酒与黑啤饮用量带来负面影响,除非 政府能够有效地落实'缴税印花'的措施。

本集团预料在可预见的未来,业者将继续面对高水平的竞争。本集团将全力以赴集中资源捍卫其啤酒市场的领导地位, 同时提高其黑啤市场占有额。

有鉴于此,本集团预料2005年将是极富挑战性的年头。

கண்ணோட்டம்

2004ஆம் ஆண்டு மலேசிய புரூவரி தொழிற்துறைக்கு மிகவும் சவால் மிக்க ஆண்டாகும். 12 செப்டம்பர் 2003ல் பீருக்கும் ஸ்டாவுட்டுக்கும் விதிக்கப்பட்ட10 விழுக்காடு வரி அதிகரிப்பினால் ஏற்பட்ட விளைவுகளிலிருந்து முழுமையாக மீள்வதற்கு முன்பாக, 10 செப்டம்பர் 2004ல் அரசாங்கம் பீருக்கு 26.3%உம் ஸ்டாவுட்டுக்கு 23.0%உம் வரி உயர்வை அறிவித்தது. இதனால் ஏற்பட்ட விலை உயர்வு உள்நாட்டில் வரி செலுத்தப்பட்ட பீர், ஸ்டாவுட் விற்பனை சந்தையின் வளர்ச்சியில் குறிப்பாக 2004ன் இறுதி காலாண்டில் பாதிப்பை ஏற்படுத்தியது. ஆனால் அதே வேளையில் இறக்குமதி செய்யப்பட்ட பீருக்கும் மதுபானங்களுக்கும் 2.2% இலிருந்து 13.6% வரையில் வரி விதிக்கப்பட்டது. இந்தக் குறைவான வரி உயர்வு உள்நாட்டு பீர், ஸ்டாவுட் சந்தையின் நிலைமையை மேலும் பாதித்தது.

குறைந்த விலைக்கு விற்கப்படும் இறக்குமதி பீர்களின் அதிகரிப்பாலும் கள்ளத்தனமாகக் கொண்டுவரப்படும் பீர்கள் சுலபமாக கிடைப்பதாலும் உள்நாட்டுப் பீர், ஸ்டாவுட் சந்தை தொடர்ந்து பாதிக்கப்பட்டு வருகிறது.

1 மார்ச் 2005இலிருந்து இறக்குமதி செய்யப்படும் எல்லா பீர்களுக்கும் மதுபான விளைபொருள்களுக்கும் வரிகள் செலுத்தப்பட்டுள்ளதை உறுதிப்படுத்துவதற்கு அரசாங்கம் ''வரி முத்திரைகள்'' என்ற திட்டத்தை அறிமுகப்படுத்தியுள்ளது. இது எந்த அளவிற்குப் பயன் விளைவுள்ளதாக இருக்கும் என்பது இன்னும் சரிவரத் தெரியவில்லை. அதே வேளையில், மலேசியாவிலுள்ள பீர், ஸ்டாவுட் தொழில் நிறுவனங்களிடையே நிலவி வரும் போட்டித் தன்மைகளும் அதிகமாகவே காணப்படுகின்றன.

இந்தச் சூழ்நிலையிலும் பீர் சந்தையில் தலைமைத்துவத்தைக் குரூப் தொடர்ந்து தற்காத்து வருகிறது. மேலும், புதிய யுக்திகளையும், விற்பனை நடவடிக்கைகளில் புதிய வழி முறைகளையும் கையாண்டு ஸ்டாவுட் சந்தையில் பாராட்டத்தக்க அளவிலான பங்குகளைத் தற்காத்து வருகிறது.

நீர்வாக முடிவுகள்

மதிப்பீடு செய்யப்படும் ஆண்டிற்கான குரூப் வருமானம் 12.4% அல்லது RM 108.8 மில்லியனாக உயர்ந்தது, அதாவது RM 984.8 மில்லியனாகும். செப்டம்பர் 2003க்குப் பிறகு வருமான வரியில் ஏற்றம் ஏற்பட்டதால் விலை ஏற்றம் கண்டது. ஏற்றுமதி அதிகரித்தது. இவையே வருமானத்தில் உயர்வு ஏற்படதற்கு அடிப்படைக் காரணங்களாகும். குரூப்பின் வரிக்கு முந்தைய இலாபம் RM 113.3 மில்லியனாகும். இது 2003ஆம் ஆண்டை விட 6.2% அல்லது RM 6.7 மில்லியன் கூடுதலாகும். வருமான ஏற்றமே ஆதாய உயர்வுக்கு முக்கிய காரணமாகும்.





Euro 2004 - the 'Official Beer' since Euro 88

Carlsberg Malaysian Open and Carlsberg Golf Classic

Golf has been an integral part of Carlsberg's involvement in sports, having made giant strides in golf sponsorships in the country. The prestige, the tradition and the excitement of the Royal and Ancient game perfectly fit the Carlsberg image.

It all started in 1986 with the inception of the Carlsberg Trophy an inter club golf game among the armed forces golf clubs in the country.

Carlsberg Golf Classic

In December 2004, Chia Kim Seng made it two wins in a row for Singapore with his success in the Carlsberg Golf Classic National Final. Various charities have benefited from the charitable efforts organised through the Classic. Since its introduction in 2000, a total of RM405,000 has been raised and channeled to deserving charities.

Carlsberg Malaysian Open

Carlsberg's entry into professional golf sponsorships in 1999 was memorable with the 1999 World Cup won by Tiger Woods amongst a field of world class players and the Women's World Cup of Golf a year later, which included superstar Annika Sorenstam. After two years as the presenting sponsor, Carlsberg became the title sponsor for the 40th edition of the Malaysian Open.

The 42nd edition of the Carlsberg Malaysian Open in February 2004, jointly sanctioned by the Asian and European Tours, offered a US\$1.21 million prize money. It attracted top European players like Padraig Harrington, Paul McGinley, Miguel Angel Jimenez and also Asian star players like Zhang Lian-wei, Jyothi Randhawa and Thongchai Jaidee. Thongchai Jaidee emerged as the winner, becoming the first Thai to win the 2004 Carlsberg Malaysian Open and also a golf tournament in the European PGA Tour. The tournament was telecast in over 50 countries.

Cobra 10s - long-serving commitment since 1985



Education, Welfare and Research Foundation of Malaysia - supporting the less privileged



To this end, the Board continues to implement the recommendations of the Malaysian Code of Corporate Governance ("Code"), which sets out the principles and best practices on structures and processes that companies may use in their operations towards achieving the optimal governance framework.

COMPLIANCE STATEMENT

- Determining all questions of policy and expediency that may arise in the administration of the ESOS and exercising such powers and performing such acts where necessary.

II. Board Balance

Following the organisational changes of CBMB's major shareholder, Carlsberg Asia Pte Ltd, where the responsibility for the Asian region was transferred from Carlsberg Asia Pte Ltd to Carlsberg Breweries A/S, the then Managing Director of CBMB, Mr Bjorn Sondenkov, resigned on 1 July 2004 to move back to Carlsberg Breweries A/S to support the organisational change. For the purposes of continuity, Dato' Jorgen Bornhoft, the then Chairman of CBMB, and who was also previously the Managing Director of CBMB prior to Mr Bjorn Sondenskov's appointment, was appointed as the Executive Chairman on 1 July 2004. Dato' Jorgen Bornhoft's position as Executive Chairman combined the roles of Chairman and Managing Director. The strong independent element of the Board, whereby 50% were independent, ensured a balance of power and authority during this time.

On 1 January 2005, upon the appointment of Mr Mogens Joenck as Managing Director, Dato' Jorgen Bornhoft's Board position changed from Executive Chairman to Non-Executive Chairman. Accordingly, the roles and responsibilities of the Chairman and Managing Director are made clearly distinct to further enhance the existing balance of power and authority.

Except for the period from 1 July 2004 to 31 December 2004, the Chairman holds a Non-Executive position and is primarily responsible for matters pertaining to the Board and the overall conduct of the Group. The Managing Director oversees the running of the Group and the implementation of the Board's decisions and policies.

In 2004, the Board had 8 members, comprising 6 Non-Executive Directors and 2 Executive Directors. Out of the 8 Directors, 4 were Independent Directors, which is in excess of the statutory requirement of one-third. Collectively, the Directors bring a wide range of business, legal, financial and technical experience relevant to the Group. The profile of each Director is summarised under pages 5 to 9.

The presence of Independent Non-Executive Directors ensures that issues of strategies, performance and resources proposed by the Management are objectively evaluated, taking into consideration the long-term interests of shareholders, employees, customers, suppliers and other communities in which the Group conducts its business. The relatively large number of Independent Directors also ensure that the investment of minority shareholders is fairly reflected through Board representation.

III. Supply of Information

All Directors are furnished with a comprehensive Board File including the meeting agenda usually at least 2 weeks before each Board meeting. Sufficient time is given to enable the Directors to solicit further explanations and/or information, where necessary, so that deliberations at the meeting are focused and constructive.

The Board File includes, amongst others, sales and marketing development and strategies, financial results and forecasts, status of major projects, minutes of meetings of the Audit Committee and other major operational, financial and legal issues. In addition, there is a schedule of matters reserved specifically for the Board's decision.

All Directors have access to the advice and services of the Company Secretary as well as to all information within the Group. There is also a formal procedure sanctioned by the Board of Directors, whether as a full board or in their individual capacity, to take independent professional advice, where necessary and in appropriate circumstances, in furtherance of their duties, at the Group's expense.

IV. Appointments to the Board

The Code endorses, as good practice, the setting up of a Nomination Committee to formalise procedures for appointments to the Board. Although the Code states that this procedure may be performed by the Board as a whole, as a matter of best practice, it recommends that this responsibility be delegated to a committee.

To this end, the Nomination Committee is charged with the responsibility of, amongst others, recommending the appointment of new Directors to the Board.

Carlsberg has an induction and education programme for new Board members, which includes a visit to the brewery and discussions with the Managing Director, Department Heads and Key Section Heads to better understand the operations, business and policies of the Group, which will allow the Director to contribute effectively from the outset of the appointment. The relevant sections of the Listing Requirements of Bursa Securities particularly in relation to their responsibilities as Directors, are also conveyed to them.

V. Re-election

In accordance with the Company's Articles of Association, all Directors are subject to election at the first Annual General Meeting after their appointment.

The Articles also provide that at least one third of the Directors be subject to re-election by rotation at each Annual General Meeting. Directors over 70 years of age are required to submit themselves for re-appointment at every Annual General Meeting in accordance with Section 129(6) of the Companies Act, 1965.

B. DIRECTORS' REMUNERATION

I. Remuneration Policy

The objective of the Group's remuneration policy is to attract and retain the Directors required to lead and control the Group effectively. In the case of Executive Directors, the components of the remuneration package are linked to corporate and individual performance. For Non-Executive Directors, the level of remuneration is reflective of their experience and level of responsibilities.

Statement of Corporate Governance (contd.)

II. Remuneration Procedure

The Remuneration Committee recommends for the Board's approval, the framework of executive remuneration of the Executive Directors' remuneration package.

Non-Executive Directors' fees are determined by the Board as a whole with the Director concerned abstaining from deliberations and voting on decisions in respect of his fee.

The fees payable to Directors are subject to the approval of shareholders.

III. Details of Remuneration

Details of the number of Executive and Non-Executive Directors in remuneration bands of RM50,000 for the year ended 31 December 2004 are disclosed in the Statutory Accounts as Note 7 of the Notes to the Financial Statements.

C. INVESTOR RELATIONS AND SHAREHOLDER COMMUNICATION

The Board recognises the importance of an effective communications channel between the Board, shareholders and general public.

The annual reports, press releases, quarterly results and any announcements on material corporate exercises are the primary modes of disseminating information on the Group's business activities and financial performance.

The Annual General Meeting represents the principal forum for dialogue and interaction with shareholders. At every meeting, the Board sets out the progress and performance of the Group since the last meeting held. Shareholders are encouraged to participate in the subsequent question and answer session wherein Directors, Company Secretary, Heads of Department as well as the Group's External Auditors are available to respond to the queries raised. In the event that an answer cannot be readily given at the meeting, the Chairman will undertake to provide a written reply to the shareholder.

Each item of special business included in the notice of meeting will be accompanied by a full explanation of the effects of a proposed resolution.

During the year, the Managing Director and/or key management personnel also hold discussions with the press and analysts when necessary, to provide information on the Group's strategy, performance and major developments. A press briefing is also held after each Annual General Meeting.

In addition, the Group maintains a website at www.carlsberg.com.my for shareholders and the public to access information on, amongst others, the Group's background and products, financial performance, frequently-asked questions (FAQs) and updates on its various sponsorships and promotions.

D. ACCOUNTABILITY AND AUDIT

I. Financial Reporting

In presenting the annual financial statements and quarterly announcement of results to shareholders, the Board takes responsibility in conveying a balanced and understandable assessment of the Group's position and prospects.

A statement by Directors of their responsibilities in preparing the financial statements is set out on page 52 of this Annual Report.

II. Internal Controls

The Board of Directors has always placed significant emphasis on sound internal controls which are necessary to safeguard the Group's assets and shareholders' investment. To this end, the Board affirms its overall responsibility for the Group's internal controls system which encompasses risk management practices as well as financial, operational and compliance controls. However, it should be noted that such system, by its nature, manages but not eliminates risks and therefore can provide only reasonable, and not absolute, assurance against material misstatement, loss or fraud.

Ongoing reviews are performed throughout the year to identify, evaluate, monitor and manage significant risks affecting the business and ensure that adequate and effective controls are in place. Such continuous review processes are conducted by the Group's independent and sufficiently resourced internal audit function as well as the management team. The findings of the internal audit function are regularly reported to the Audit Committee.

III. Relationship with Auditors

The role of the Audit Committee in relation to the external auditors is described on pages 50 to 51.

Responsibility

The Board is committed to the continuous improvement of internal controls and risk management practices within the Group to meet its business objectives. The Board affirms its overall responsibility for the effectiveness of the Group's systems of internal controls and risk management, and for reviewing the adequacy and integrity of these systems to safeguard shareholders' investment, customers' interest and the Group's assets. However, such systems, by their nature, can only provide reasonable, and not absolute, assurance against material misstatement, loss and fraud. These systems are designed to manage, rather than eliminate, the risk of failure to achieve business objectives of the Group.

Risk Management Framework

The Group has in place an ongoing process for identifying, evaluating, monitoring and managing the significant risks affecting the achievement of its business objectives. This is a continuous process, subject to regular review by the Board, and accords with the "Statement on Internal Control: Guidance for Directors of Public Listed Companies". The key elements of the Group's Risk Management Framework are described below :-

Structure

The Group adopts a decentralised approach to risk management, whereby all employees take ownership and accountability for risks at their respective levels. The process of risk management and treatment is overseen by the Heads of Department.

A working group, the Risk Management Working Committee ("RMWC"), provides risk management support to Management for the Group as a whole. The role of the RMWC includes periodic reporting of the status of risk mitigation actions, new risks identified and risks that have changed characteristics together with corresponding controls. The RMWC comprising key persons from all departments, submits its reports to both the Management and the Audit Committee. The Audit Committee reports to the Board on any significant changes in the business and external environment which affect key risks.

In 2004, the RMWC met 6 times wherein discussions and reviews were conducted on key risks faced by the Group, their corresponding controls and action plans to be taken. The RMWC's feedback was reported to the Management and the Audit Committee on a regular basis.

Risk Assessment

The Group maintains a database of key risks specific to the Group together with their corresponding controls, which are categorised as follows :-

- Strategic, which are risks that affect the overall direction of the business
- · Operational, which are risks that impact the delivery of the Group's products and services
- Financial, which are risks associated with financial processes and reporting
- Knowledge, which are risks associated with intellectual property and information resources

During the year, the database of key risks and corresponding controls were reviewed for completeness and adequacy. The identified risks were prioritised according to the degree of impact and likelihood of occurrence. Existing corresponding controls were assessed for adequacy, taking into account the level of risk involved and where necessary and feasible, additional controls were identified for implementation.

Internal Control System

The key elements of the Group's internal control system are described below :-

• Control Environment

The importance of a proper control environment is emphasised throughout the organisation. Focus is directed towards the quality and abilities of the Group's employees with continuing education and training to enhance the skills of employees and reinforce qualities of professionalism and integrity. Such training also includes internal briefings and external seminars for selected employees to enhance the level of awareness and knowledge on matters relating to risk management and internal controls.

• Control Structure

The Board and Management have established an organisation structure with clearly defined lines of accountability and delegated authority. This includes well-defined responsibilities of Board committees and various management levels, including authorisation levels for all aspects of the business.

The key elements of the Group's control structure are as follows :-

Management

- Management has introduced well-established standard operating procedures that cover all key aspects of the Group's various business processes. These policies and procedures deal with, amongst others, control issues for financial accounting and reporting, treasury management, asset security, information technology, health and safety, etc. The procedures are subject to regular reviews to cater for process changes, changing risks or further improvements.
- Aside from the standard operating procedures, changes in internal control procedures are also communicated via circulars and internal memos. Such circulars and memos are properly authorised by the relevant members of senior management.
- Regular visits by the head office personnel to sales depots.
- Regular meetings with the Heads of sections/sales areas which provide a sound platform for the members of the sections/sales areas to communicate with, and provide feedback to and from, Management.

• Internal Audit

The Group has an Internal Audit Department which carries out its functions independently and provides the Audit Committee and the Board with the assurance on the adequacy and integrity of the system of internal controls. The Internal Audit Department is solely responsible for planning, implementing and reporting the audits. For this purpose, each year, the Department :

- Prepares a detailed Annual Audit Plan in consultation with the Managing Director for submission to the Audit Committee for approval;
- Carries out all activities to conduct the audits in an effective, professional and timely manner;
- Reports to the auditee upon completion of each audit; and
- Submits quarterly reports to the Audit Committee.

The Audit Committee Report set out on pages 49 to 52 of this Annual Report contains further details on the principal responsibilities and activities of the Internal Audit Department in 2004.

Statement on Internal Control (contd.)

Audit Committee

The Audit Committee, on behalf of the Board, regularly reviews the measures undertaken on internal control issues identified by the RMWC, Internal Audit, external auditors and Management. During the year, 39 reports were issued by the Internal Audit Department to the Audit Committee for their review.

The Audit Committee Report set out on pages 49 to 52 of this Annual Report contains further details on the activities undertaken by the Audit Committee in 2004.

• Board

The Board holds regular discussions with the Audit Committee and Management and considers their reports on matters relating to internal controls and deliberates on their recommendations for implementation.

• Reporting and Information

Business plans are prepared by Management and form the basis for detailed budgets. The detailed budgets are prepared by business operating units and reviewed and approved by Management, the Board and the major shareholder.

The monitoring of results against budget is conducted every quarter, with major variances followed up and management action taken, where necessary. The budget is reviewed every quarter to update for any changes in the business, financial and operating environment.

Regular and comprehensive information is provided to Management, covering financial performance and key business indicators, key operating statistics/indicators, key business risks, legal, environmental and regulatory matters. Weekly meetings attended by Management, which includes the Managing Director/ Executive Chairman, are held to discuss the various aspects of the business, financial and operational performance of the Group. Key matters affecting the Group are brought to the attention of the Audit Committee and are reported to the Board on a regular basis. Management also ensures that it has the knowledge of key market information in respect of the Group's products and takes pro-active measures, as appropriate, in the best interests of the Group.

• Monitoring and Review

There are processes for monitoring the system of internal controls and reporting any significant weaknesses together with details of corrective action.

The system is reviewed on an ongoing basis by the Board (through the Audit Committee), Management, Finance Department and Internal Audit Department. Responsibility for monitoring compliance with policies, procedures and guidelines rests principally with the Internal Audit Department, which reports directly to the Audit Committee as described above. Heads of Department are also actively involved in continually improving the control processes within their respective departments.

Review of Effectiveness

The Directors have taken the necessary steps to ensure that appropriate systems are in place for the assets of the Group to be adequately safeguarded through the prevention and detection of fraud and other irregularities and material misstatements.

The Directors believe that the system of internal controls is considered appropriate to business operations, and that the risks taken are at an acceptable level within the context of the business environment of the Group.

During the year, a number of improvements to internal controls were identified and addressed. There have been no significant weaknesses noted which have resulted in any material losses.

This Statement on Internal Control does not deal with the associated company as the Group does not have management control over its operations.

This statement is made in accordance with a resolution of the Board of Directors dated 23 February 2005.

MEMBERSHIP AND MEETINGS

TERMS OF REFERENCE

• Terms of membership

- 1. The Audit Committee shall be appointed by the Board from amongst their number and shall consist of not less than 3 members with the majority being Independent Directors.
- 2. The members of the Audit Committee shall elect a Chairman from amongst their number who shall be an Independent Non-Executive Director.
- 3. At least 1 member of the Audit Committee must be or have the following :-
 - a member of the Malaysian Institute of Accountants; or
 - at least 3 years' working experience and have passed the examinations specified in Part 1 of the 1st Schedule of the Accountants Act 1967 or be a member of one of the associations of accountants specified in Part II of the 1st Schedule of the Accountants Act 1967; or
 - a degree/masters/doctorate in accounting or finance with at least 3 years' post qualification experience in accounting or finance; or
 - at least 7 years' experience being a chief financial officer of a corporation or having the function of being primarily responsible for the management of the financial affairs of a corporation.
- 4. In the event of any vacancy in the Audit Committee, the Board shall within 3 months of that event, appoint such new members to make up the minimum number of 3 members.
- 5. No alternate director can be appointed as a member of the Audit Committee.
- 6. The term of office and performance of the Audit Committee and each of its members shall be reviewed by the Board at least once in every 3 years.

Authority

The Audit Committee is authorised by the Board to perform the following :-

- 1. To investigate any matter within its terms of reference. It shall have full and unrestricted access to any information pertaining to the Group, both the internal and external auditors and to all employees of the Group. It shall have the resources required to perform its duties.
- 2. To obtain external legal or other professional advice and secure the attendance of outsiders with relevant experience to attend, if necessary.
- 3. To promptly report to the Bursa Malaysia Securities Berhad ("Bursa Securities"), any matter reported by it to the Board which has not been satisfactorily resolved resulting in a breach of the Bursa Securities Listing Requirements.

• Functions

The functions of the Audit Committee shall be :

- 1. to review the following and report the same to the Board of Directors :-
 - (a) with the external auditor, the audit plan;
 - (b) with the external auditor, his evaluation of the system of internal controls;
 - (c) with the external auditor, his audit report, including his Management letter and Management's response;
 - (d) with the external auditor, any other matter he may wish to discuss (in the absence of Management where necessary);
 - (e) the assistance given by the Company's officers to the external auditor;
 - (f) the adequacy of the scope, functions and resources of the internal audit function and that it has the necessary authority to carry out its work;
 - (g) the internal audit programme, processes, the results of the internal audit programme, processes or investigation undertaken and whether or not appropriate action is taken on the recommendations of the internal audit function;
 - (h) any appraisal or assessment of the performance of members of the internal audit function;
 - (i) any appointment or termination of senior staff members of the internal audit function;
 - (j) any resignations of internal audit staff members and provide the resigning staff member an opportunity to submit his reasons for resigning;
 - (k) the quarterly results and year end financial statements of the Company and of the Group, prior to the approval by the Board, focusing particularly on :-
 - (i) changes in or implementation of major accounting policy changes;
 - (ii) significant and unusual events;
 - (iii) compliance with accounting standards and other legal requirements;
 - (iv) significant adjustments arising from the audit;
 - (v) going concern assumption;
 - (l) any related party transaction and/or conflict of interest situation that may arise within the Company or Group including any transaction, procedure or course of conduct that raises questions of management integrity;
 - (m) any major findings of internal investigations and Management's response;
 - (n) the quarterly reports relating to Risk Assessment and the effectiveness and appropriateness of the Risk Management Framework; and
- 2. to recommend and consider the nomination and appointment of a person or persons as external auditors, the audit fees and any questions of resignation or dismissal; and
- 3. to consider any other functions as may be agreed to by the Audit Committee and the Board of Directors.

• Meetings

- 1. Meetings shall be held not less than 4 times a year.
- 2. The quorum for each meeting shall be two independent Members of the Audit Committee.
- 3. The Chief Financial Officer, the Head of Internal Audit and the external auditor shall normally attend meetings. Other Board members and employees may attend meetings only upon the invitation of the Audit Committee.
- 4. At least once a year, the Audit Committee shall meet with the external auditor without executive board members present. The external auditor may also request a meeting if they consider that one is necessary.
- 5. The Company Secretary shall be the Secretary of the Audit Committee.

• Reporting Procedures

The Secretary shall circulate the minutes of meetings of the Audit Committee to all members of the Board.

• Internal Audit Function

The Group has an established Internal Audit Department which assists the Audit Committee in the discharge of its duties and responsibilities. In attaining such objectives, the following activities were carried out by the Internal Audit Department in 2004 :-

- 3. assessed the means of safeguarding assets and verified their existence;
- 4. appraised the reliability and usefulness of the information developed within the Group for Management;

- 6. identified opportunities to improve the operations of, and processes within, the Group; and

- Considered and recommended to the Board for approval of the audit fees payable.
- Considered the independence and objectivity of the external auditors and the services provided, including non-audit services. Non-audit services totalling RM51,000 were payable to the external auditors during the year for tax advisory services.
- Reviewed the Internal Audit Department's resource requirements, programmes and plan for the year under review and the annual assessment of the Department's performance.

- Reviewed the internal audit reports, recommendations and Management's response. Discussed actions taken with Management to improve the internal controls system based on internal audit findings.
- Reviewed the Risk Management Framework and reports summarising the findings from work performed on the identification and assessment of enterprise-wide key risks.
- Reviewed the audited financial statements of the Company and the Group prior to the submission to the Board for their consideration and approval. The review was to ensure that the audited financial statements were drawn up in accordance with the provisions of the Companies Act, 1965 and the applicable accounting standards approved by Malaysian Accounting Standards Board ("MASB").
- Reviewed the quarterly unaudited financial results announcements before recommending them for the Board's approval. The review and discussions were conducted with the Chief Financial Officer.
- Reviewed the Company's compliance with the Listing Requirements of Bursa Securities, MASB and other relevant legal and regulatory requirements.
- Reviewed pertinent issues of the Group which had a significant impact on the results of the Group which included enhancement and further investment in existing products, cost rationalisation measures and human resource development.
- Reviewed the significant related party transactions entered into by the Group.
- Reviewed the extent of the Group's compliance with the provisions set out under the Malaysian Code on Corporate Governance for the purpose of the Statement of Corporate Governance pursuant to the Listing Requirements of Bursa Securities.

In preparing the financial statements for the financial year ended 31 December 2004, the Directors have applied appropriate and relevant accounting policies consistently and in accordance with applicable accounting standards and made judgments and estimates that are reasonable and fair.

The financial statements are prepared on a going concern basis and the Directors have ensured that proper accounting records are kept which enable the preparation of the financial statements with reasonable accuracy.

1. CORPORATE INFORMATION

The principal activities of the Company and the Group are the production of beer, stout, shandy and non-alcoholic beverages for distribution in the home market and for export. There have been no significant changes in the nature of the principal activities during the financial year.

The Company is a public limited liability company, incorporated and domiciled in Malaysia, and is listed on the Main Board of the Bursa Malaysia Securities Berhad ("Bursa Securities"). The registered office of the Company is located at No. 55, Persiaran Selangor, Section 15, 40200 Shah Alam, Selangor Darul Ehsan.

The directors regard Carlsberg Asia Pte Ltd, a company incorporated in the Republic of Singapore, as the holding company and Carlsberg Breweries A/S, a company incorporated in Denmark, as the ultimate holding company of Carlsberg Brewery Malaysia Berhad.

The numbers of employees in the Company and in the Group (including executive directors) at the end of financial year were 275 (2003: 283) and 622 (2003: 623) respectively.

The financial statements were authorised for issue by the Board of Directors in accordance with a resolution of the directors on 23 February 2005.

2. SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of Preparation of Financial Statements, and Changes in Accounting Policies

The financial statements of the Company and of the Group are prepared under the historical cost convention modified to include the revaluation of certain property, plant and equipment, and comply with the provisions of the Companies Act, 1965 and applicable Approved Accounting Standards issued by the Malaysian Accounting Standards Board (MASB). The Company and the Group have applied certain transitional provisions as allowed under MASB Standard No.15, 'Property, Plant and Equipment', by virtue of which a reporting enterprise is allowed to retain revalued amounts on the basis of previous revaluations (subject to continuity in depreciation policy and the requirement to write an asset down to its recoverable amount). Accordingly, the valuations of these assets have not been updated and their carrying amounts are stated as deemed cost.

(b) Basis of Consolidation

The consolidated financial statements incorporate the financial statements of the Company and all its subsidiary companies for the year to 31 December. The results of subsidiary companies acquired or disposed of are included in the consolidated financial statements from the date of acquisition or up to the date of disposal.

(c) Property, Plant and Equipment, and Depreciation

Property, plant and equipment are stated at cost modified by the revaluation of certain land and buildings, less accumulated depreciation, amortisation and impairment losses. The policy for the recognition and measurement of impairment losses is in accordance with Note 2(p).

Freehold land is not depreciated.

Leasehold land is depreciated over the periods of the leases ranging from 43 to 99 years.

(c) Property, Plant and Equipment, and Depreciation (Contd.)

Depreciation on other property, plant and equipment is calculated on the original cost or subsequent valuation of property, plant and equipment and is charged on a straight line basis at varying rates to write off assets over their estimated economic lives. The principal annual depreciation rates applied are as follows:

Buildings	-	2% - 2.5%
Plant and machinery	-	at rates varying from 5% to 20%
Furniture and equipment	-	20% - 33.3%
Motor vehicles	-	20%

Upon the disposal of an item of property, plant or equipment, the difference between the net disposal proceeds and the net carrying amount is charged or credited to the income statement and any attributable portion of the revaluation surplus is taken directly to retained earnings.

(d) Dividends

Dividends from long term investments, and in respect of the Company, from subsidiary and associated companies, are recognised in the income statement upon the right to receipt of such dividends being established.

(e) Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on a weighted average basis. Cost includes the actual cost of materials and incidentals in bringing the inventories into store, and for finished goods and workin-progress, also includes labour and attributable production overheads. In arriving at net realisable value, due allowance is made for all obsolete and slow moving items.

(f) Provision for Doubtful Debts

Known bad debts are written off and provision is made for debts individually reviewed by customer accounts or categories and identified as doubtful.

(g) Provisions for liabilities

Provisions for liabilities are recognised when the Group has a present obligation as a result of a past event and it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation, and a reliable estimate of the amount can be made. Provisions are reviewed at each balance sheet date and adjusted to reflect the current best estimate. Where the effect of the time value of money is material, the amount of a provision is the present value of the expenditure expected to be required to settle the obligation.

(h) Foreign Currencies

Transactions in Foreign Currencies

Transactions in foreign currencies are recorded at the rates of exchange prevailing at the dates of the respective transactions and where settlement has not taken place at the balance sheet date, the balances are translated at approximate rates then prevailing. Exchange differences arising are taken to the income statement.

Translation of Foreign Currency Financial Statements

The Group's share of net assets and results of foreign associated companies are translated at rates of exchange ruling at the balance sheet date. The translation differences arising are taken to Exchange Reserve.

(h) Foreign Currencies (Contd.)

(i) Revenue recognition

(i) Sale of goods

Revenue is recognised when the significant risks and rewards of ownership of the goods have passed to the buyer.

(ii) Interest and rental income

Interest income and rental income are recognised on an accrual basis.

(j) Employees Benefits

(i) Short term benefits

Wages, salaries, bonuses and social security contributions are recognised as an expense in the year in which the associated services are rendered by the employees of the Group. Short term accumulated compensated absences such as paid annual leave are recognised when services are rendered by employees that increase their entitlement to future compensated absences, and short term non-accumulating compensated absences such as sick leave are recognised when the absences occur.

(ii) Defined contribution plans

Retirement benefits for employees are paid by way of statutory monthly contributions, and where contracted and eligible, at rates over and above the minimum statutory contributions, to the statutory Employees Provident Fund or to an approved, separately funded defined contribution scheme. Contributions are charged to the income statement as and when the obligations arise.

(iii) Termination benefits

Termination benefits are recognised as a liability and an expense when the Group has a detailed formal plan for the termination without realistic possibility of withdrawal.

(k) Income Tax

Income tax on the profit or loss for the year comprises current and deferred tax. Current tax is the expected amount of income taxes payable in respect of the taxable profit for the year and is measured using tax rates that have been enacted at the balance sheet date.

Deferred tax is provided for, using the liability method, on temporary differences at the balance sheet date between tax bases of assets and liabilities and their carrying amounts in the financial statements. In principle, deferred tax liabilities are recognised for all taxable temporary differences and deferred tax assets are recognised for all deductible temporary differences, unused tax losses and unused tax credits to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

(k) Income Tax (Contd.)

Deferred tax is measured at tax rates that are expected to apply in the period when the asset is anticipated to be realised or the liability is anticipated to be settled, based on tax rates that have been enacted or substantively enacted at the balance sheet date. Deferred tax is recognised in the income statement, except when it arises from a transaction which is recognised directly in equity, in which case the deferred tax is also charged or credited directly in equity.

(l) Subsidiary Companies

The consolidated financial statements include the financial statements of the Company and all its subsidiaries. Subsidiaries are those companies in which the Group has a long term equity interest and where it has power to exercise control over the financial and operating policies so as to obtain benefits therefrom.

Subsidiaries are consolidated using the acquisition method of accounting. Under the acquisition method of accounting, the results of subsidiaries acquired or disposed of during the year are included in the consolidated income statement from the effective date of acquisition or up to the effective date of disposal, as appropriate. The assets and liabilities of a subsidiary are measured at their fair values at the date of acquisition and these values are reflected in the consolidated balance sheet. The difference between the cost of an acquisition and the fair value of the Group's share of the net assets of the acquired subsidiary at the date of acquisition is included in the consolidated balance sheet as goodwill or negative goodwill arising on consolidation.

Intra-group transactions, balances and resulting unrealised gains are eliminated on consolidation and the consolidated financial statements reflect external transactions only. Unrealised losses are eliminated on consolidation unless costs cannot be recovered.

Investments in subsidiary companies are stated in the financial statements of the Company at cost unless, in the opinion of the directors, there has been a permanent diminution in value, in which case an appropriate provision is made.

(m) Associated Companies

An associated company is defined as a company, not being a subsidiary company, in which the Group has a long term interest of not less than 20% of the equity and in whose financial and operating policy decisions the Group exercises significant influence.

Investments in associated companies are stated in the financial statements of the Company at cost unless, in the opinion of the directors, there has been a permanent diminution in value, in which case an appropriate provision is made. The Group equity accounts for its share of post-acquisition results and reserves of associated companies.

(n) Long Term Investments

Long term investments are stated at cost unless in the opinion of the directors there has been a permanent diminution in value, in which case provision is made for the diminution in value.

(o) Cash and Cash Equivalents

The statements of cash flow, prepared using the indirect method, classify changes in cash and cash equivalents according to operating, investing and financing activities. For the purposes of the cash flow statements, cash and cash equivalents comprise cash on hand and at bank, deposits with licensed financial institutions, and short-term, highly liquid investments that are readily convertible to known amounts of cash and which are not subject to significant risk of changes in value.

(p) Impairment of Assets

At each balance sheet date, the Group reviews the carrying amounts of its assets (other than inventories, deferred tax assets, assets arising from employee benefits and financial assets which are reviewed pursuant to the relevant accounting policies) to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, impairment is measured by comparing the carrying values of the assets with their recoverable amounts. Recoverable amount is the higher of net selling price and value in use, which is measured by reference to discounted future cash flows. Recoverable amounts are estimated for individual assets or, if it is not possible, for the cash-generating unit to which the asset belongs.

An impairment loss is charged to the income statement immediately, unless the asset is carried at revalued amount. Any impairment loss of a revalued asset is treated as a revaluation decrease to the extent of any available previously recognised revaluation surplus for the same asset.

Reversal of impairment losses recognised in prior years is recorded when there is an indication that the impairment losses recognised for the asset no longer exist or have decreased. The reversal is recognised to the extent of the carrying amount of the asset that would have been determined (net of amortisation and depreciation) had no impairment loss been recognised. The reversal is recognised in the income statement immediately, unless the asset is carried at revalued amount. A reversal of an impairment loss on a revalued asset is credited directly to revaluation surplus. However, to the extent that an impairment loss on the same revalued asset was previously recognised as an expense in the income statement, a reversal of that impairment loss is recognised as income in the income statement.

(q) Financial Instruments

Financial instruments are recognised in the balance sheet when the Group has become a party to the contractual provisions of the instrument.

Financial instruments are classified as liabilities or equity in accordance with the substance of the contractual arrangement. Interest, dividends, gains and losses relating to a financial instrument classified as a liability, are reported as expense or income. Distributions to holders of financial instruments classified as equity are charged directly to equity. Financial instruments are offset when the Group has a legally enforceable right to offset and intends to settle either on a net basis or to realise the asset and settle the liability simultaneously.

(i) Marketable Securities

The Group does not own any marketable securities other than those held as long term investments.

(ii) Trade Receivables

Trade receivables are carried at anticipated realisable values. Bad debts are written off when identified. An estimate is made for doubtful debts based on a review of outstanding amounts as at the balance sheet date, 31 December, as stated in Note 2(f).

(iii) Trade Payables

Trade payables are stated at cost which is the fair value of the consideration to be paid in the future for goods and services received.

2. SIGNIFICANT ACCOUNTING POLICIES (CONTD.)

(q) Financial Instruments (Contd.)

(iv) Equity Instruments

Ordinary shares are classified as equity. The transaction costs of an equity transaction, other than in the context of a business combination, are accounted for as a deduction from equity, net of tax. Equity transaction costs comprise only those incremental external costs directly attributable to the equity transaction which would otherwise have been avoided.

Dividends on ordinary shares are recognised in equity in the period in which they are declared.

When the share capital of the Company is repurchased, the consideration paid, including any attributable transaction costs is presented as a change in equity. Repurchased shares are classified as treasury shares and presented as a deduction from equity. No gain or loss is recognised in the income statement on the sale, re-issuance or cancellation of treasury shares. Consideration received is presented in the financial statements as a change in equity.

3. REVENUE

Revenue represents the value of the gross sales of goods less returns, discounts and sales tax.

4. COST OF SALES

Cost of sales represents cost of inventories sold.

The Group operates principally in the brewing industry in Malaysia, in the production and sale of beer, stout, shandy and nonalcoholic beverages. The other segments are not significant. Accordingly, information analysing geographical and industry segments is not presented.

29. FINANCIAL INSTRUMENTS

Financial Risk Management Objectives and Policies

The Group's financial risk management policies seek to ensure that adequate financial resources are available for the development of the Group's business whilst managing its foreign exchange and credit risks. The Group operates within clearly defined guidelines that are approved by the Board and the Group's policy is not to engage in speculative transactions.

(a) Foreign Exchange Risks

The objectives of the Group's foreign exchange policies are directed at enabling the Group to manage exposures that arise from transactional activities within a framework of controls that does not expose the Group to unnecessary foreign exchange risks. The Group covers substantially all foreign exchange exposures arising from its foreign currency payables and on cash flows to be applied in anticipated transactions denominated in foreign currencies, through foreign currency deposits.

(b) Credit Risks

Credit risks, or the risk of counter parties defaulting, are controlled by the application of credit approvals, limits and monitoring procedures. Trade receivables are monitored on an ongoing basis through Group management reporting procedures. All deposits are placed with licensed financial institutions, which are assessed for acceptable creditworthiness.

The Group does not have any significant exposure to any individual customer or counter party nor does it have any major concentration of credit risk related to any financial instrument.

(c) Liquidity Risks

As part of the Group's overall liquidity management, the Group maintains sufficient levels of cash or cash convertible investments to meet its working capital requirements.



An agreement between Carlsberg Marketing Sdn Bhd ("CMSB"), a wholly owned subsidiary of CBMB, and CAPL dated 1 January 2002 for the appointment of CMSB as sole and exclusive distributor of products manufactured in CBMB's brewery. The royalties payable by CMSB is based on an agreed formula. A supplemental agreement between CMSB and CAPL dated 29 July 2004 which varies the terms of the said agreement between CMSB and CAPL dated 1 January 2002 by including the trade mark name of "Skol" with royalties payable by CMSB based on an agreed formula.
- 5. A novation of licence agreement dated 30 September 2004 between CBMB, CBAS and CAPL for CAPL to transfer to CBAS all its rights, title and interests in the agreement between CBMB and CAPL dated 1 January 2002 for, inter-alia, the exclusive use of trade mark names and the supply of technical and commercial assistance by CAPL.
- 6. A novation of licence agreement dated 30 September 2004 between CMSB, CBAS and CAPL for CAPL to transfer to CBAS all its rights, title and interests in the agreement between CMSB and CAPL dated 1 January 2002 for the appointment of CMSB as sole and exclusive distributor of products manufactured in CBMB's brewery.
- 7. An agreement between CBMB, CAPL and Carlsberg Singapore Pte Ltd ("CSPL"), a wholly-owned subsidiary of CAPL, dated 2 January 2003 for the production and supply of products manufactured by CBMB to CSPL for sale and distribution in the Republic of Singapore.
